At the Forum's fall meeting, members identified a number of streams under the broad umbrella of mental health, resiliency and the future of work for the health care workforce including

- The increasing incidences and impact of violence in the workplace on the healthcare workforce;
- Increased impact of existing stressors exacerbated by the COVID-19 pandemic, including staffing shortages, limited support structures and resources for the workforce, etc.;
- Erosion of public trust in the healthcare and public health workforce over the past two years; and

- Impacts of various changes identified, or expanded, during the COVID-19 pandemic, such as an increased use of telehealth and other virtual engagement tools, that will fundamentally alter the nature of the public health and medical workplace going forward.

To help determine potential next steps by the Forum, in this discussion it would be helpful if members could drill down on what topic areas under this large umbrella issue would be most valuable to them to be explored in the near term, and what might make sense for a fall/winter workshop focus for the coming year.
